The "ICSI" and the "Om Sterling Global University, Hisar" are hereinafter, collectively referred to as the 'PARTIES' and individually as a 'PARTY'.

- I. The Institute of Company Secretaries of India (ICSI) is the only recognized professional body in India to develop and regulate the profession of Company Secretaries in India.
- II. **Om Sterling Global University, Hisar**, is a co-educational, residential, private research university located in the city of Hisar in Haryana, India.
