

MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

OM INSTITUTE OF TECHNOLOGY & MANAGEMENT, HISAR

AND

INDIAN INSTITUTE OF TECHNOLOGY BOMBAY

This MOU is made on 12.06.2014 by and between Om Institute of Technology & Management, Hisar having a registered office at Chandigarh Road (NH-65), Juglan, Hisar-125001 (Haryana) hereinafter referred to as "RC" (Remote Center), of the FIRST PART,

AND

Indian Institute of Technology, Bombay, a research and educational institution in technology and engineering disciplines enjoying the status of a deemed university, having its registered office at Powai Mumbai-400 076, India, hereinafter referred to as "IITB", which expression, unless repugnant to the context shall mean and include its successors and assigns, of the SECOND PART.

PREAMBLE

The Centre for Distance Engineering Education Programme (CDEEP) was established at IITB to reach out to a wider student community in the country and abroad. CDEEP is concerned with all that is involved in the teaching and learning processes. This covers evolving of educational communication tools and techniques, creating, planning and effective usage of teaching and learning aids.

RC is desirous of participating as a Remote Center in the Distance Engineering Education Programme being conducted by CDEEP, IITB under the broad terms and conditions as stated hereunder.



1. SCOPE OF THE MOU

The scope of this MOU will be to participate as a Remote Center in the Distance Engineering Education Programmes, hereinafter referred to as "CDEEP Programmes", conducted by IITB.

2. MODES OF PARTICIPATION THROUGH Remote Center (RC):

Candidates can participate in distance programmes in five modes:

- a. Live Classroom: Here, the RC will receive free lectures of IIT Bombay faculty through EDUSAT, the satellite dedicated to the education field. IITB will offer courses

Epidemics, Riots, Civil Commotions etc. provided on the occurrence and cessation of any such event the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force majeure conditions continue beyond six (6) months, the parties shall jointly decide about the future course of action.

13. AMENDMENT

Any addition, deletion and / or alteration to this Agreement may be effected with a written agreement by both Parties to this Agreement by mutual consent concerning the amendments. A document containing the additions, deletions and / or alterations, signed by both Parties hereto, shall form an annexure to and be deemed to be a part of this Agreement.


14. RESOLUTION OF DISPUTES

- a. In case of any question, dispute or differences arising out of or in connection with this agreement or breach, termination or validity thereof, such question, dispute or difference will be resolved by mutual discussions at the first instance. Unresolved disputes, if any, shall be subject to resolution by the good offices of the higher authorities of the two institutions. If the dispute cannot be resolved by the said manner, the matter shall be referred to Director IITB as the sole arbitrator for arbitration. The venue of arbitration shall be Mumbai.
- b. This Agreement shall be governed by the Laws of India and the Parties hereto shall submit to the exclusive jurisdiction of Courts of Mumbai.






