

MEMORANDUM OF UNDERSTANDING

THIS MOU is entered on 10th February, 2020, between OM STERLING GLOBAL UNIVERSITY, HISAR (India) hereinafter referred to as OSGU and London School of Executive Training, London (UK) hereinafter referred to as LSET.

It is mutually agreed between the parties:

- 1. That the parties enter this Agreement to provide for extensive collaboration between the two institutions to offer joint enrolment in approved programs leading to the issuance of academic Certificates as per the provision of this agreement.
- 2. This agreement provides for OSGU students to be jointly enrolled in LSET in various programs/courses offered by them.
- Besides the above-mentioned program, LSET and OSGU may jointly decide to introduce other academic programs from time to time for such courses OSGU and LSET will mutually specify registration fees and other fees to be paid by each student to OSGU and LSET.
- 4. For any course or program in which OSGU enrolment is permitted, OSGU shall have the right to review and monitor the academic content and educational methodology to determine compliance with OSGU's academic standards.
- Based upon the completion of the required minimum number of days/hours on a
 particular programme and after completing the LSET and OSGU requirements,
 students will be eligible for their respective awards by LSET.
- The LSET faculty/resource person will be responsible for administering, evaluating, and grading the training program. OSGU will assist in providing pattern/contents of the training program.
- 7. OSGU shall have the right to review information pertaining to the academic credentials of methods of instruction and academic procedures relating to any or programs for which students are enrolled. OSGU shall have the right to make site visits to observe academic instruction and training materials are in conformity with OSGU standards, and to assure that quality training is provided consistent with the requirements of OSGU.
- Students enrolling in programs sponsored by LSET, OSGU will pay a registration fee
 to LSET. The student registration fee for the various programs training programs and
 other fees will be payable as decided by LSET.
- OSGU may, at its own cost, include information on LSET in OSGU mailings sent to its prospective students worldwide.

- 10. LSET may provide additional services to OSGU, subject to additional agreements between the two parties for the provision of these additional services, in such areas as consultancy for planning and setting up of campus facilities, recruitment and training of faculty, program management, program delivery and instruction, advertising and promotion, and examination design, evaluation and management.
- 11. OSGU agrees to abide by all rules and regulations of LSET including compliance with any statute, rule, or regulation of the State and the UGC.
- 12. LSET agrees to promptly provide to OSGU a full description of instructional methods used for assigning, monitoring, evaluating work, and awarding Certificate.
- 13. LSET will be independent in operational matters of its programs including financial and administrative aspects. However, LSET will follow all policy matters as set forth in this document or issued as official policy of OSGU from time to time. Policy decisions shall mutually be respected by both LSET and OSGU.
- 14. LSET will maintain in good shape all academic, administrative, and financial records pertaining to OSGU programs, and shall make those records available for review on demand by OSGU authorities.
- 15. This Agreement shall be for a period of 5 years (beginning 10th February, 2020 and running through 10th January 2025.
- 16. After 10th January 2025on wards, the MoU may be renewed for additional periods of 5 years for each renewal. Renewal may occur by the mutual written agreement of both parties. In the event either party breaches the contract by failing to fulfil any of the duties set forth, notice of such breach shall be provided in writing to the other party. If the violation of the Agreement is not corrected within thirty (30) days, the contract may be declared as terminated.

17. Vice Chancellor, Om Sterling Global University, Hisar (India) and Chairman of London School of Executive Training, London (UK) shall remain responsible for this agreement of cooperation between these two institutions.
