2nd INTERNATIONAL MOOT COURT COMPETITION 2024

The School of Legal Studies , Om Sterling Global University , Hisar is organizing its " 2^{nd} International Moot Court Competition 2024" on 22^{nd} & 23^{rd} April, 2024

MOOT COURT - RULES & REGULATIONS

ADMINISTRATION & GENERAL RULE

- Organizer means the School of Legal Studies, Om Sterling Global University.
- Competition means 2nd International Moot Court Competition, 2024.
- Participating Team/Institution means the team that has registered itself for the competition as per the rules.

TIME, DATE & VENUE:

- The 2nd International Moot Court Competition, 2024, shall be held in two stages on 22nd & 23rd April, 2024.
- Venue: Moot Court (SLS), Om Sterling Global University, Hisar.

LANGUAGE:

• The official language for the 2nd International Moot Court Competition shall be English only.

ELIGIBILITY:

• The Competition is open to all students, enrolled bonafide on regular basis in an undergraduate/postgraduate law programme or its equivalent conducted by any recognized College/Institution/University.

TEAM COMPOSITION:

- Each participating university/college/institute can nominate a team consisting of three students, out of whom, two will be speakers and one will be the researcher.
- No additional member will be entertained and shall not be eligible for local hospitality. He/She shall also be not entitled to any kind of prize/award in the competition.

DRESS CODE:

Participants are required to adhere to the following dress code while present in Court Room during the Competition.

- Girl Participants: White shirt and black trouser/black skirt along with black tie, black blazer and black shoes or white kurta with black legging.
- Boy Participants: White shirt, black trousers, black tie along with black blazer and black shoes.
- Strict adherence to the dress code is solicited.
- Failure shall result in disqualification.

ACCOMMODATION:

- Accommodation shall be provided to the Semi-finalist participants and for the finalist on 21st & 22nd April.
 Accommodation is not chargeable, it is free of cost.
- Teams that intend to arrive prior to or leave after the specified dates are required to make their own arrangements.

REGISTRATION:

- The registration of team is considered to be complete, once the registration fee is paid and the registration form is emailed with all necessary details.
- Registration fees once paid will not be refunded.
- Every team which has registered under the Rules shall be allotted a unique code. Once the unique code has been allotted, every team must use the team code for any communication with the organizers during the course of the Competition.

STRUCTURE OF THE COMPETITION:

• The formal commencement of the competition shall be from 22nd April, 2024 The competition will start with the inaugural ceremony, followed by a draw of lots on 22nd April, 2024

• The Preliminary Round will take place on the 22nd April, 2024 in online/offline mode. Quarter finals will take place on the 22nd April, 2024 in online/offline mode respectively. The Semi-finals and finals will be conducted on 23rd April, 2024 in online/offline mode followed by the valedictory session. Certificates and Prizes will be distributed only during the valedictory session. No prize/certificate will be given in absentia.

PRELIMINARY ROUND:

- There shall be preliminary round on 22nd April, 2024 and every team shall be given the opportunity to argue for each side.
- Each team shall get a total time of 15 minutes to present their case and the time for 'rebuttal' and 'surrebuttal' is 5 minutes. Any extension of time beyond the specified period shall be subject to the discretion of judges.
- The division of time between the speakers is the discretion of the team members, subject to a maximum of 8 minutes for one speaker.
- At the end of the preliminary round, the top 8 teams will qualify for the Quarter Finals.
- A team shall be credited with a win, if its total marks in the respective session are higher than those of its opponent team.
- If the situation of the tie still persists, then it would be resolved, by considering the memorial scores.

QUARTER FINALS:

- The Quarter Finals will be a ranking round and will take place on 22nd April, 2024 in online/offline mode. The top 4 teams, with the highest total scores in these oral rounds shall qualify for the semi-final rounds.
- The side to be represented by a team shall be determined by way of draw of lots with the teams picking the lots after the completion of the preliminary round.
- Each team shall get a total time of 20 minutes to present their case and the time for 'rebuttal' and 'surrebuttal' is 5 minutes. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members, subject to a maximum of 10 minutes for one speaker.

SEMIFINALS:

- The Semi-Finals will be a ranking round and will take place on 23rd April, 2024. The top 2 teams, with the highest total scores in these oral rounds shall qualify for the Final rounds.
- The side to be represented by the team shall be determined by way of draw of lots with the teams picking the lots after the completion of quarter-finals rounds.
- Each team shall get a total of 25 minutes to present their case and the time for 'rebuttal' and 'surrebuttal' is 5 minutes. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers in the discretion of the team members, subject to a maximum of 13 minutes for one speaker.

FINALS:

- The Final will be held on 23rd April, 2024. A team will be credited with a win in the Final if the total marks are higher than those of its opponent team.
- Each team shall get a total of 30 minutes to present their case and the time for 'rebuttal' and 'surrebuttal' is 5 minutes. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members, subject to a maximum of 15 minutes for one speaker.

MEMORIAL RULES:

- All memorials submitted for all purposes of the Competition shall strictly adhere to the rules of the Competition.
- Each Team participating in the Competition must prepare one Memorial on behalf of Petitioner(s)/Appellant(s)/

- Prosecution(s) and one on behalf of the Respondent(s)/Defence(s).
- Each team has to submit 3 hard/soft copies of the Memorials from each side before preliminary round on 19th April, 2024.
- Prosecution(s)/Appellant(s) memorials are required to have a light blue cover and Defence(s)/Respondent(s) memorials are required to have a bright red cover.
- The memorials shall not contain any form of identification apart from the team code. If any such identification or mark, symbol, etc. which has the effect of identifying the team is found on the memorial, then it shall result in instant disqualification.
- The hard copy of memorial must be exact replica of the soft copy submitted with the Organizers. Any difference in the same will result in disqualification from the Competition.
- Each Team must send a soft copy of their memorials, in PDF format only, to mootcourt@osgu.ac.in and also send a hard copy of their memorials for evaluation by 19th April, 2024 to the following address: OM STERLING GLOBAL UNIVERSITY (School of Legal Studies), NH-52, Hisar-Chandigarh Road, Hisar-125001 Haryana with the subject "Memorials for 2nd International Moot Court Competition 2024"

- The scanned copy of approval letter duly signed by the Chairperson/Head of the participating Institute confirming the participation of respective team shall also be uploaded in the Google form.
- Registration Fee for the team-1500/- (Rupees One Thousand five hundred Only), for College/Institution/University.
- Registration Fee is a **NON-REFUNDABLE**, in case of non-participation or otherwise as may deem fit.

- The organizing committee reserves the right, at its sole discretion, to take appropriate action for any unethical, unprofessional and wrongful conduct during the entire period of the Moot Court competition.
