VARIATION

The MOU can be amended by a written agreement duly signed by authorized representative of both parties.

CONFIDENTIALITY AND CONDITIONS

a) All information and documents to be exchanged pursuant to this Memorandum of Understanding will be kept confidential by the Parties and will he used subject to such terms as each Party may specify. A Party will not use the information for purposes other than that specified without the prior written consent of the other Party.

b) All Confidential information shall remain the exclusive property of the disclosing Party. The Parties agree that the disclosure of the Confidential Information do not grant or imply any license, interest or right to the Recipient in respect to any intellectual property right of the other Party.

DURATION

The MOU shall be effective from the date of its signing by both the Parties, shall be valid for a period of five years from that date and is extendable for a further period if refund.

TERMINATION

Either Party may terminate this MOU by giving one month's notice in writing to the other. The termination of this MOU shall not affect the implementation of any specific activities established under it prior to such termination.

FUNDING

It is understood that the implementation of any of the type of co-operation stated in agreement shall depend upon the availability of resources and financial support of the Parties concerned.

Except as otherwise provided or agreed, the parties shall each bear their own costs and expenses incurred in complying with their obligations under this MOU.

Both parties shall remain liable for any losses or liabilities incurred due to their own or their employee's actions and neither party intends that the other party shall be liable for any loss it suffers as a result of this MOU.
