**Best paper/poster presentation award:** To motivate and acknowledge the efforts of participants, one outstanding paper/poster from each category (Pharmaceutical Sciences, Health Sciences, and Applied Sciences) will be selected for the Best Paper/Poster Presentation Award. The winners will be determined based on a merit list compiled by an expert panel after a thorough evaluation of all submissions.

All delegates will receive a certificate of participation or presentation in recognition of their contribution to the event.

## GUIDELINES FOR SUBMISSION

1. **Abstract:** The abstract should be concise, within 200 words, and must include relevant keywords. It should be placed as the first paragraph of the full paper.
2. **Author Details:** Include the names of the author and co-authors, along with their affiliations, complete addresses, email IDs, and contact numbers clearly.
3. **Formatting:**
  - Use Times New Roman, font size 12 pt.
  - Maintain 1.5 line spacing and one-inch margins on all sides.
  - The text should be justified on both sides.
  - The paper should begin with the title, followed by author details, then the abstract and keywords.
4. **Title:** The title should be descriptive yet concise, not exceeding 40 words.
5. **Length of the Paper:** The full paper should be limited to 1500 words, including tables and figures, or a maximum of 6 A4-sized pages.
6. **Submission:** Submit the paper in MS Word format, along with the payment receipt, via email to: [intconf123@osgu.ac.in](mailto:intconf123@osgu.ac.in)
