



Memorandum of Understanding (MOU)

Between

Tribhuvan University, Kirtipur Kathmandu Nepal.

And

**Om Sterling Global University,
NH-52, Hisar-Chandigarh Road, Hisar (Haryana) India.**

Introduction

Tribhuvan University (TU), founded in 1959, is the first national institute of Higher Education in Nepal, serving the people and enriches the global learning community by extended advantages of higher education.

Om Sterling Global University (OSGU), Hisar (Haryana) India is a University established by an Act of Govt. of Haryana (India) under the Haryana State Private Universities Establishment Act No. 32 of 2006 and approved under section 2(f) of the University Grants Commission Act, 1956. Backed by rich and wide experience in academic dispensation, OSGU aims at unrivalled learning environment, self-development, career orientation and holistic transformation empowering the students to be the catalyst for vibrant and inclusive society.

Purpose

The purpose of this Memorandum of Understanding (MOU) is to encourage, facilitate and qualitatively strengthen the pursuit of mutually beneficial academic relations between TU hereinafter referred to as Party-I and OSGU hereinafter referred to as Party-II. Whereas both the Parties wish to promote academic teaching, learning, collaborative research and agree to recognize and approve the degrees awarded by the respective Universities and also agree to extend cooperation in the following areas:

- Cooperation on academic programs
- Development of joint research activities
- Faculty exchange and /or visiting programs for teaching and research
- Student exchange and /or visiting programs for research and study
- Participation in seminars and academic meetings
- Exchange of academic materials, results of teaching and research collaboration and other information

- Any other activities viewed to be mutually beneficial
- Any extra points may be added to this MOU on mutual consent of both the parties. Specific projects can be developed and shared based on the agreement.

The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both Parties prior to the initiation of such activities and will be subject of separate agreements.

Term

This MOU becomes effective from the day the representatives of both Parties affix their signatures below, and will continue for an initial period of five (5) years, whereupon it will be reviewed and may be extended by mutual written agreement of both Parties. This MOU may be amended through the mutual agreement of both parties. This MOU may be terminated by either party upon providing six (6) months prior written notice signed by an authorized representative of the notifying Party.


General

The Parties agree that there is no intention to share any confidential or proprietary information in any collaboration under this MOU. If either Party desires to disclose information of a confidential or proprietary nature, the Parties will enter into a separate written confidentially agreement.


Treatment of Intellectual property rights developed through collaboration under this MOU will be determined by the Parties through mutual consultation and separate written agreements on a case by case basis.
